

PRIVACY POLICY AND CONSENT DECLARATION

for Processing of Personal Data at Company Events

The purpose of this Privacy Policy is to provide natural persons participating in the events of the Chemaxon Kft. (Hungary, 1138 Budapest, Váci út 133.) and its affiliates ("**Data Controller**" or "**Chemaxon**") with information on data processing concerning them. Chemaxon will also use this document to obtain your consent as a data subject ("**Data Subject**") to the processing of your personal data in accordance with the following, and to comply with the *Regulation (EU)* 2016/679 Of The European Parliament And Of The Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC.

PROCESSING ACTIVITIES

1.) Data processing related to the data provided during registration

In certain cases, Chemaxon requires prior registration for participation in its programmes, events and workshops ("Events"). Registration is conditional upon you being familiar with this Privacy Policy and making a declaration to that effect. The provision of certain information is at your discretion, but without your full name and email address, registration will not be accepted.

The purpose of processing the data is to provide the necessary communication during the organisation of the Event (to inform you of useful information about participation in the Event - location, start, approach, programme, etc.), to identify the natural person attending and to provide access to the Event venue.

Purpose of data processing	Communication related to the Event and providing access to it.



Period of the data processing	2 years after the end of the Event / Until consent is withdrawn.
Legal basis for the processing	Consent of the Data Subject

2.) Taking of photographs or making voice and video recordings and the use of these footages

Chemaxon's staff will take photographs and make voice and video recordings at the Event. The footage will be available on Chemaxon's own website and other social media platforms ("Websites"). Chemaxon may use photographs, voice and video recordings based on the voluntary consent of the participants.

Types of personal data processed	Image (still and video image) and voice
Purpose of data processing	Recording of (still and video) images, and voice, and publishing the same for sales promotion and online marketing purposes
Legal basis for the processing	Consent of the Data Subject
Period of the data processing	Until consent is withdrawn. The Data Controller shall use its best efforts to withdraw or delete the disclosed recordings in order to enforce the withdrawal of consent, but due to the nature of Internet technology, the restriction shall only bind the Data Controller for the period following the date of the withdrawal of consent.
Recipients of the personal data	Visitors of Chemaxon's office, Website or social media platforms

What are your data protection rights?

Chemaxon would like to make sure you are fully aware of all your data protection rights. Every Data Subject is entitled to the following:

Under certain circumstances, by law you have the right to:

- **Request access** to your personal information (commonly known as a "data subject access request"). This enables you to receive a copy of the personal information we hold about you and to check that we are lawfully processing it.
- **Request correction** of the personal information that we hold about you. This enables you to have any incomplete or inaccurate information we hold about you corrected.
- **Request erasure** of your personal information. This enables you to ask us to delete or remove personal information where there is no good reason for us continuing to process it. You also have the right to ask us to delete or remove your personal information where you have exercised your right to object to processing (see below).
- **Object to processing** of your personal information where we are relying on a legitimate interest (or those of a third party) and there is something about your particular situation which makes you want to object to processing on this ground.



• Request the restriction of processing of your personal information. This enables you to ask us to suspend the processing of personal information about you, for example if you want us to establish its accuracy or the reason for processing it.

Right to withdraw consent

In any circumstances where you may have provided your consent to the processing of your personal information for a specific purpose, you have the right to withdraw your consent for that specific processing at any time. Once we have received notification that you have withdrawn your consent, we will no longer process your information for the purpose or purposes you originally agreed to.
